### **S\*1014 (Rat #0260, Act #0247 of 1996) General Bill, By McConnell, Courson, Passailaigue, L.E. Richter and M.T. Rose Similar (H 4448)**

A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 54-7-100, so as to establish the Hunley Commission to negotiate with the United States Government on behalf of the State of South Carolina concerning the Submarine H. L. Hunley to ensure that the Submarine and any human remains located therein remain in South Carolina in perpetuity and are displayed in an appropriate manner for the benefit of future generations and to provide that the geographical coordinates of the Hunley's location are exempt from disclosure under the Freedom of Information Act.-amended title
