### **S\*1160 (Rat #0693, Act #0565 of 1990) General Bill, By I.E. Lurie**

A Bill to amend Chapter 53 of Title 59, Code of Laws of South Carolina, 1976, relating to technical and vocational education and training, by adding Article 23 so as to establish and fund a program of motorcycle safety instruction and provide that a discount insurance rate may be made available for certified graduates of the program.
