### **S\*0150 (Rat #0066, Act #0034 of 1981) General Bill, By Senate Banking and Insurance**

#### ***Similar (S 0069)***

A Bill to amend Section 38-35-460, Code of Laws of South Carolina, 1976, as amended, relating to optional provisions in accident and health insurance policies, so as to require the insurer writing such policies to ascertain the amount of insurance an applicant has in force with such insurer at the time of application for additional coverage and to require the insurer to provide the applicant with the total amount of coverage when the applicant has life, accident and health insurance enforced with such insurer.-at
