A Bill to amend Section 12-7-310, as amended, Code of Laws of South Carolina, 1976, relating to income tax exemptions, so as to, among other things, provide an exemption of two thousand dollars to an individual who has adopted a "special needs child" and furnishes the child's chief support, and to define the term, "special needs child".-amended title
