### **S\*0177 (Rat #0112, Act #0058 of 1991) General Bill, By S.S. Martschink and Wilson**

A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 15-75-50 so as to prohibit the use of a facsimile machine to transmit unsolicited advertising material which offers to sell goods or services and provide exceptions and for civil action; to amend the 1976 Code by adding Section 15-75-51 so as to provide when the penalty for violations of Section 15-75-50 may be imposed; and to provide an exemption from the Sections.-amended title
