AN ACT TO AMEND THE SOUTH CAROLINA CODE OF LAWS BY AMENDING SECTION 1-31-10, RELATING TO THE COMMISSION FOR MINORITY AFFAIRS, SO AS TO RENAME THE COMMISSION AND TO REMOVE COMMISSION MEMBERSHIP REQUIREMENTS; BY AMENDING SECTION 1-31-20, RELATING TO SUBJECTS OF STUDY FOR THE COMMISSION, SO AS TO STUDY SOCIO-ECONOMIC DEPRIVATION OF COMMUNITIES; AND BY AMENDING SECTION 1-31-40, RELATING TO DUTIES OF THE COMMISSION, SO AS TO DELETE CERTAIN DUTIES. - RATIFIED TITLE
