### **S\*0216 (Rat #0290, Act #0209 of 1989) Joint Resolution, By Senate Finance**

A Joint Resolution to provide that the time for filing of applications for property tax exemption required by Section 12-3-145, Code of Laws of South Carolina, 1976, for taxable years 1981 through 1989 is extended until July 1, 1989, and to provide that the time for filing of applications for property tax exemption for property of a local farmer-owned nonprofit marketing authority for taxable years 1980 through 1988 is extended until July 1, 1989.-amended title
