

## Session 112 - (1997-1998)

### **S\*0233 (Rat #0192, Act #0122 of 1997) General Bill, By Hayes and Russell**

A BILL TO AMEND SECTION 4-37-30, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO LOCAL SALES AND USE TAXES FOR TRANSPORTATION FACILITIES, SO AS TO PROVIDE THAT THE TAX MAY BE IMPOSED FOR SINGLE OR MULTIPLE PROJECTS; TO CLARIFY THE TYPES OF PROJECTS FOR WHICH THE PROCEEDS OF THE TAX ARE TO BE USED; TO REQUIRE THAT THE REFERENDUM HELD BEFORE A TAX MAY BE IMPOSED NOT BE HELD MORE OFTEN THAN ONCE IN TWELVE MONTHS AND MUST BE HELD ON THE TUESDAY FOLLOWING THE FIRST MONDAY IN NOVEMBER; AND TO DELETE OBSOLETE PROVISIONS; AND TO AMEND SECTION 4-37-20, RELATING TO THE RIGHTS AND POWERS OF THE BOARD OF TRANSPORTATION AUTHORITY CREATED BY THE GOVERNING BODY OF A COUNTY, SO AS TO DELETE THE POWER OF EMINENT DOMAIN, FROM THE POWERS OF THE BOARD AND TO PROVIDE THAT THE BOARD MAY RECOMMEND TO THE COUNTY GOVERNING BODY THAT PROPERTY BE ACQUIRED THROUGH EMINENT DOMAIN, AND IF THE PROPERTY IS TO BE ACQUIRED THROUGH EMINENT DOMAIN, THE GOVERNING BODY WILL COMMENCE THE PROCEEDINGS.-AMENDED TITLE
