A Bill to amend Section 12-7-2240, as amended, Code of Laws of South Carolina, 1976, relating to tax refunds to taxpayers by the South Carolina Tax Commission and to amend Section 43-5-220, as amended, relating to obtaining support payments from absent parents, so as to authorize the Tax Commission to give to the Department of Social Services certain information relating to the identity and address of taxpayers entitled to a state income tax refund who also owe past-due support obligations.-amended title
