### **H\*2869 (Rat #0211, Act #0125 of 1983) General Bill, By House Agriculture and Natural Resources**

A Bill to amend Section 50-13-250, Code of Laws of South Carolina, 1976, relating to the daily limit on trout, so as to provide that the Wildlife and Marine Resources Department may promulgate regulations to regulate trout fishing in portions of Matthews Creek, Middle Saluda River, Eastatoe River, Whitewater River and Lake Jocassee.
