**H\*2963 (Rat #0778, Act #0657 of 1988) General Bill, By P. Evatt, D.M. Beasley and Hayes**

***Similar (S 0686)***

A Bill to amend Section 43-5-235, Code of Laws of South Carolina, 1976, relating to the reimbursement of local entities for costs of child support collection and paternity determination programs, so as to revise the provisions allowing for reimbursements for costs for children by providing reimbursement when the children have sought assistance in securing support whether or not they are eligible for Aid to Families with Dependent Children and regardless of the economic circumstances and provide for payment of a fiscal incentive to the Department for collection and enforcement of absent parent support obligations and reinvestment of the incentive if it is not owed to a contracting entity.-amended title
