### **H\*3075 (Rat #0189, Act #0110 of 1999) General Bill, By Limehouse, Edge, Simrill and Emory**

**Summary:** Sex offender registry, release of offender's name and residence; sheriff; Law Enforcement, Crimes and Offenses

A BILL TO AMEND THE CODE OF LAWS OF SOUTH CAROLINA, 1976, BY ADDING SECTION 23-3-530 SO AS TO REQUIRE THE STATE LAW ENFORCEMENT DIVISION TO DEVELOP AND MAINTAIN A PROTOCOL MANUAL TO BE USED BY CONTRIBUTING AGENCIES IN THE ADMINISTRATION OF THE SEX OFFENDER REGISTRY; AND TO AMEND SECTION 23-3-490, AS AMENDED, RELATING TO SEX OFFENDER REGISTRY INFORMATION BEING AVAILABLE TO THE PUBLIC, SO AS REQUIRE A SHERIFF TO PROVIDE A LISTING OF THE REGISTRY FOR PUBLICATION BY A NEWSPAPER WITH GENERAL CIRCULATION IN THE COUNTY, TO PROVIDE IMMUNITY FROM LIABILITY FOR PROVIDING OR PUBLISHING SUCH INFORMATION ABSENT INTENT, MALICE, OR BAD FAITH, AND TO REQUIRE A SHERIFF TO NOTIFY THE PRINCIPAL OF PUBLIC AND PRIVATE SCHOOLS AND THE ADMINISTRATORS OF DAY CARE CENTERS OF AN OFFENDER RESIDING WITHIN ONE-HALF MILE OF THE SCHOOL OR DAY CARE CENTER.-AMENDED TITLE
