**Summary:** Joint Municipal Electric Power and Energy Act

AN ACT TO AMEND SECTIONS 6-23-20, 6-23-30, AND 6-23-40, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO THE JOINT MUNICIPAL ELECTRIC POWER AND ENERGY ACT, SO AS TO MAKE GRAMMATICAL CHANGES AND CORRECT ARCHAIC LANGUAGE, TO DELETE THE REQUIREMENT THAT THE ACQUISITION OF A PROJECT BE BY PURCHASE FROM AN ELECTRIC SUPPLIER GENERALLY SERVING THE AREA IN WHICH THE MEMBERS ARE LOCATED; AND TO AMEND SECTION 6-23-60, RELATING TO FILING A PETITION BY A JOINT AGENCY WITH THE PUBLIC SERVICE COMMISSION WITH INFORMATION NECESSARY FOR THE COMMISSION TO MAKE A DETERMINATION OF AN ACQUISITION, SO AS TO ADD A PROVISION REQUIRING THE COMMISSION TO TAKE INTO CONSIDERATION WHETHER THE EFFECT OF THE ACQUISITION WOULD HAVE AN EFFECT ON THE AUTHORITY OF THE JOINT AGENCY TO SATISFY EXISTING FINANCIAL AND CONTRACTUAL OBLIGATIONS THAT IT MAY HAVE INCURRED IN THE ACQUISITION OF ANY PREVIOUSLY ACQUIRED PROJECTS. - ratified title
