### **H\*3141 (Rat #0466, Act #0380 of 1996) General Bill, By Neilson, T. Brown, J. Hines, Inabinett and Lloyd**

A Bill to amend Section 6-11-91, Code of Laws of South Carolina, 1976, relating to compensation and benefits for the governing body of a special purpose district or public service district, so as to provide for reimbursement for expenses actually incurred subject to the limits imposed for members of state boards, committees, and commissions, and to allow the district to set the amount of per diem.-amended title
