### **H\*3366 (Rat #0220, Act #0101 of 1997) General Bill, By J.H. Hodges**

A BILL TO AMEND THE CODE OF LAWS OF SOUTH CAROLINA, 1976, BY AMENDING SECTION 20-7-545, RELATING TO IMMUNITY FROM CIVIL AND CRIMINAL LIABILITY, SO AS TO INCLUDE THE IMMUNITY A LAW ENFORCEMENT OFFICER WHO TAKES A CHILD INTO EMERGENCY PHYSICAL CUSTODY OR EMERGENCY PROTECTIVE CUSTODY, AND TO REQUIRE THE DEPARTMENT OF SOCIAL SERVICES TO ESTABLISH STATEWIDE GUIDELINES FOR INTERVENTION IN CASES OF EXCESSIVE CORPORAL PUNISHMENT.-AMENDED TITLE
