**Summary:** Radioactive waste disposal

A BILL TO AMEND SECTION 48-46-40, AS AMENDED, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO VOLUME LIMITATIONS ON THE DISPOSAL OF LOW-LEVEL RADIOACTIVE WASTE, SO AS TO ESTABLISH A TOTAL VOLUME LIMIT OF FORTY THOUSAND CUBIC FEET INCLUDING NONREGIONAL WASTE FOR FISCAL YEAR 2008 THROUGH FISCAL YEAR 2023; AND TO AMEND SECTION 48-46-50, RELATING TO VOTING BY SOUTH CAROLINA COMMISSIONERS OR ALTERNATE COMMISSIONERS TO THE ATLANTIC COMPACT COMMISSION, SO AS TO DIRECT THE COMMISSIONERS AND ALTERNATE COMMISSIONERS TO VOTE IN A MANNER TO AUTHORIZE THE IMPORTATION OF NONREGIONAL WASTE SO LONG AS IMPORTATION WOULD NOT CAUSE THE FACILITY TO EXCEED A TOTAL VOLUME LIMIT OF FORTY THOUSAND CUBIC FEET FOR FISCAL YEAR 2008 THROUGH FISCAL YEAR 2023.
