### H\*3555 (Rat #0282, Act #0261 of 2000) General Bill, By Allison and Rodgers

**Summary:** Minors, child abused, neglected; inflicting great bodily injury upon a violent crime; abuse resulting in death

A BILL TO AMEND SECTION 16-3-85, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO HOMICIDE BY CHILD ABUSE, SO AS TO DEFINE THE TERMS "CHILD ABUSE OR NEGLECT" AND "HARM"; BY ADDING SECTION 16-3-95 SO AS TO CREATE FELONY OFFENSES FOR INFILCTING OR KNOWINGLY ALLOWING ANOTHER TO INFILCT GREAT BODILY INJURY UPON A CHILD, TO PROVIDE AN EXCEPTION FOR CORPORAL PUNISHMENT OR PHYSICAL DISCIPLINE ADMINISTERED BY A PARENT OR PERSON IN LOCO-PARENTIS IN A MANNER WHICH DOES NOT CAUSE GREAT BODILY INJURY, AND TO PROVIDE PENALTIES; AND TO AMEND SECTION 16-1-60, AS AMENDED, RELATING TO OFFENSES WHICH ARE DEFINED AS VIOLENT CRIMES, SO AS TO INCLUDE THE INFILCTION OR ALLOWING THE INFILCTION OF GREAT BODILY INJURY UPON A CHILD.-AMENDED TITLE
