**H\*3580 (Rat #0519, Act #0467 of 1988) General Bill, By J.V. Gregory, Fair, Kirsh, P.E. Short and J.M. White**

A Bill to reauthorize the existence of the Board of Podiatry Examiners for six years; to amend Section 40-51-160, Code of Laws of South Carolina, 1976, relating to podiatry, so as to provide grounds and procedure for the suspension and revocation of licenses to practice podiatry; and to repeal Sections 40-51-210 and 40-51-250 relating to prohibition against corporate practice of podiatry or practice in connection with a commercial establishment.-amended title
