### **H\*3685 (Rat #0520, Act #0469 of 1986) General Bill, By Fair, T.A. Brett, Hayes and J.G. Mattos**

A Bill to amend Section 61-3-490, Code of Laws of South Carolina, 1976, relating to required newspaper notices of intention to apply for alcoholic liquor licenses; to amend Section 61-5-50, relating to the granting of licenses to sell alcoholic beverages in sealed containers of two ounces or less; and to amend Section 61-9-320, as amended, relating to beer and wine permits, so as to provide that a notice must also be posted on a sign at the location of the proposed business which contains certain information pertaining to the license of permit application.-amended title
