Summary: Renewable Water Resources (REWA)

AN ACT TO AMEND ACT 745 OF 1967, AS AMENDED, RELATING TO RENEWABLE WATER RESOURCES (REWA) FORMERLY KNOWN AS THE WESTERN CAROLINA REGIONAL SEWER AUTHORITY, SO AS TO AMEND REWA'S SERVICE AREA, REVISE THE MEMBERSHIP OF THE GOVERNING COMMISSION, AND TO REQUIRE REWA TO PLACE A CONSERVATION EASEMENT ON CERTAIN PROPERTY AND MAKE CERTAIN INFORMATION AVAILABLE THROUGH THE FREEDOM OF INFORMATION ACT. - ratified title
