A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 44-36-325 so as to direct the Alzheimer's Disease and Related Disorders Resource Coordination Center to develop a grant program to assist with problems relative to this disease and to require the grant recipient to provide matching funds or in-kind contributions.
