**H\*4589 (Rat #0486, Act #0398 of 1996) General Bill, By Limehouse, Cotty, J.G. Felder, R.C. Fulmer, H.M. Hallman, Hutson, Knotts and Witherspoon**

A Bill to amend Section 56-5-1210, Code of Laws of South Carolina, 1976, relating to the duties of a driver involved in an accident resulting in death or personal injury, so as to revise the penalty; and to amend Section 56-5-1220, relating to the duties of a driver involved in an accident resulting in damage to an attended vehicle, so as to revise the penalty.-amended title
