**H\*4611 (Rat #0217, Act #0176 of 2024) General Bill, By Hixon, Pope, Chapman, Taylor, Hardee, Brewer, Robbins, Gatch and Forrest**

**Summary:** Unlawful removal of electronic dog-control devices

AN ACT TO AMEND THE SOUTH CAROLINA CODE OF LAWS BY ADDING SECTION 50-11-785 SO AS TO PROHIBIT THE UNLAWFUL REMOVAL OR DESTRUCTION OF ELECTRONIC COLLARS OR OTHER ELECTRONIC DEVICES PLACED ON DOGS BY THEIR OWNERS AND TO PROVIDE PENALTIES. - RATIFIED TITLE
