### **H\*4872 (Rat #0618, Act #0456 of 1994) General Bill, By W.S. Houck**

A Bill to amend Sections 44-53-210 and 44-53-250, Code of Laws of South Carolina, 1976, relating to Schedules II and IV Controlled Substances, so as to provide that injectable forms of Pentazocine are Schedule II and that oral dosage forms of Pentazocine are Schedule IV.
