### **S\*0492 (Rat #0517, Act #0440 of 1994) General Bill, By Wilson, Ryberg and Thomas**

A Bill to amend Section 17-5-110, Code of Laws of South Carolina, 1976, relating to the authority of a coroner to carry a pistol or other handgun while engaged in his official duties, so as to extend the authority to deputy coroners; to amend Section 23-31-120, relating to permits to carry a concealed weapon, so as to make grammatical changes and to delete the bond requirement; and to repeal Section 23-1-70, relating to bonds for constables or peace officers appointed by the Governor who serve without pay.-amended title
