### **S\*0543 (Rat #0219, Act #0154 of 1987) General Bill, By Senate Fish, Game and Forestry**

A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 50-17-115 so as to provide for the prohibition of the use of various nets and seines in the waters of the State; and to repeal Sections 50-13-715, 50-17-1035, 50-17-1040, 50-17-1061, and 50-17-1066, relating to gill nets, anchor nets, or seines.-amended title
