### **S\*0554 (Rat #0458, Act #0395 of 1992) General Bill, By T.H. Pope**

A Bill to amend Chapter 5, Title 22, Code of Laws of South Carolina, 1976, relating to magistrate's powers and duties in criminal matters, by adding Article 11 so as to provide that a person convicted of a first offense in magistrate's court or municipal court may have his criminal record for this offense expunged under certain conditions; to provide exceptions; to provide procedures for keeping nonpublic records and to provide that these records may not be released under the Freedom of Information Act.-amended title
