### **S\*0606 (Rat #0252, Act #0164 of 1985) General Bill, By Senate Transportation**

A Bill to amend Section 56-5-5360, Code of Laws of South Carolina, 1976, relating to motor vehicle inspection, so as to provide for monetary penalties in lieu of revocation or suspension of licenses or permits and to make the provisions applicable to vehicle inspectors as well as to inspection stations.
