### **S\*0073 (Rat #0495, Act #0425 of 1994) General Bill, By M.T. Rose**

A Bill to amend Title 4, Code of Laws of South Carolina, 1976, by adding Chapter 20, the Community Recreation Special Tax District Act of 1994, so as to allow the establishment of a Community Recreation Special Tax District in a county by referendum, to provide the method of initiating and conducting the referendum, and to provide the powers, duties, and government of a Commission established pursuant to this Chapter, including provisions relating to the abolition of the Commission or diminution of its boundaries.-amended title
