### **S\*0889 (Rat #0505, Act #0433 of 1984) General Bill, By Senate Fish, Game and Forestry**

#### ***Similar (H 3700)***

A Bill to amend Section 50-17-1022, Code of Laws of South Carolina, 1976, relating to the use of gill nets in the Atlantic Ocean, so as to define the size of the gill nets which may be lawfully used, provide that gill nets must be adequately marked; to provide that nets must be attended at all times; to provide for the confiscation of nets and equipment illegally used; and to provide the same penalties provided in Section 50-17-1070; and to amend Section 50-17-1070, as amended, so as to add gill nets to the list of devices to which the penalties apply.-amended title
