**S\*0893 (Rat #0484, Act #0395 of 1982) General Bill, By Drummond**

***Similar (H 3729)***

A Bill to amend Chapter 37 of Title 40, Code of Laws of South Carolina, 1976, relating to opticians and optometrists, so as to delete provisions relating to opticians; to regulate optometrists; to provide penalties; and to reauthorize the existence of the South Carolina Board of Examiners in Optometry for six years in accordance with the provisions of Act 608 of 1978.
