A Bill to reauthorize the existence of the State Board of Examiners in Speech Pathology and Audiology for six years and to amend Section 40-67-10, Code of Laws of South Carolina, 1976, relating to speech/language pathologists and audiologists, so as to provide that whenever the term speech pathologist or other similar derivation of the term is used in Chapter 67 of Title 40 it means speech/language pathologist.-amended title
