**Summary:** Law enforcement training

AN ACT TO AMEND SECTION 23-23-60, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO THE ISSUANCE OF CERTIFICATES OF COMPLIANCE AND QUALIFICATION TO LAW ENFORCEMENT OFFICERS AND PERSONS TRAINED BY THE CRIMINAL JUSTICE ACADEMY, SO AS TO ESTABLISH THE MINIMUM AGE FOR CERTAIN DETENTION AND CORRECTIONAL OFFICER CANDIDATES AS EIGHTEEN YEARS OF AGE. - ratified title
