**S\*1147 (Rat #0639, Act #0558 of 1988) General Bill, By J.M. Waddell, J.C. Hayes, Leatherman and I.E. Lourie**  
**Similar (H 3667)**

A Bill to amend Section 12-43-220, Code of Laws of South Carolina, 1976, relating to classification of property for purposes of property taxation and the applicable assessment ratios, so as to provide a formula for determining fair market value for agricultural purposes for agricultural real property for tax years beginning after 1987 and to require the South Carolina Tax Commission to promulgate regulations establishing a classification for timber wetlands for purposes of property taxation.
