A Bill to amend Section 4-29-68, as amended, Code of Laws of South Carolina, 1976, relating to special source revenue bonds, so as to clarify that revenues received and retained by a county, municipality, or special purpose district from a payment in lieu of taxes pursuant to the provisions of Section 4-1-170, 4-29-60, or 4-29-67 and these revenues are derived in whole or in part from a redevelopment project are established pursuant to Chapter 6, Title 31, shall allocate the revenues in accordance with the ordinance of the municipality adopted pursuant to the provisions of Section 31-6-70 as if these revenues remained ad valorem taxes, provide that all taxes collected in the redevelopment project area not subject to the ordinance of the municipality adopted pursuant in lieu of taxes and the portion collected by the municipality may be pledged to secure special source revenue bonds; provide that any real property which is or has been included within a multicounty park under Section 4-1-170 and title to which is held by the State, may be annexed only upon approval by the Budget and Control Board; and provide that all multicounty parks must be contiguous counties.-amended title
