### **S 0152 General Bill, By McConnell, M.T. Rose and Wilson**

A BILL TO AMEND THE CODE OF LAWS OF SOUTH CAROLINA, 1976, BY ADDING SECTION 11-35-1595 SO AS TO PROVIDE FOR THE MAXIMUM SPACE ALLOCATION FOR GOVERNMENTAL BODIES ENTERING INTO NEW LEASES AND FOR EXCEPTIONS, AND FOR THE MANNER IN WHICH SUCH LEASES MAY BE APPROVED BY THE DIVISION OF GENERAL SERVICES; TO AMEND SECTION 11-35-1510, RELATING TO METHODS OF SOURCE SELECTION UNDER THE PROCUREMENT CODE, SO AS TO INCLUDE A REFERENCE TO SECTION 11-35-1595; TO AMEND SECTION 11-35-1590, RELATING TO LEASING OF REAL PROPERTY FOR GOVERNMENTAL BODIES, SO AS TO REVISE THE REQUIREMENTS OF A GOVERNMENTAL BODY WHICH PERMIT IT TO APPLY TO THE DIVISION OF GENERAL SERVICES FOR APPROVAL TO ACQUIRE RENTAL PROPERTY FOR ITS OPERATIONS WHEN STATE-OWNED PROPERTY IS NOT AVAILABLE, TO FURTHER PROVIDE FOR THE CRITERIA FOR THE APPROVAL OF SUCH AN APPLICATION, INCLUDING COST-EFFECTIVENESS AND ADEQUACY OF FUNDS, AND TO TRANSFER TO SECTION 11-35-1600 THE AUTHORITY OF THE BUDGET AND CONTROL BOARD TO PROMULGATE CERTAIN REGULATIONS PERTAINING TO RENTAL SPACE; AND TO AMEND SECTION 11-35-1600, RELATING TO THE STATE BUDGET AND CONTROL BOARD MANAGING THE LEASING OF SPACE OF STATE AGENCIES INCLUDING THE REQUIREMENT THAT THE BOARD PROMULGATE REGULATIONS IN REGARD THERETO, SO AS TO FURTHER PROVIDE FOR THESE REGULATIONS.
