A Bill to amend Section 7-15-385, Code of Laws of South Carolina, 1976, relating to absentee voting, so as to provide that the envelope in which a voter places an absentee ballot must be marked "ballot herein", to provide that the envelope may be delivered personally, by mail, or by an authorized person, and to provide a procedure for delivery by an authorized person.-amended title
