**S\*0256 (Rat #0083, Act #0045 of 1993) General Bill, By Drummond**

***Similar (H 3224)***

A Bill to amend Section 40-9-30, Code of Laws of South Carolina, 1976, relating to the establishment and powers of the Board, so as to authorize the Board to assess civil fines and collect costs for investigations and hearings and to delete duplicate provisions relating to hearing procedures; to amend Section 40-9-31, relating to revocation or suspension of a license, so as to allow assessment of a civil fine up to two thousand dollars; to repeal Section 40-9-100, relating to to disposition of excess funds; and to reauthorize the South Carolina Board of Chiropractic Examiners for six years.-amended title
