### **S\*0299 (Rat #0558, Act #0467 of 1984) General Bill, By P.B. McLeod**

A Bill to amend Section 56-7-10, as amended, Code of Laws of South Carolina, 1976, relating to uniform traffic tickets used by law enforcement officers in arrests for traffic offenses, so as to add nontraffic offenses, to provide that no other ticket may be used for those offenses, and to vest traffic recorders', and magistrates' courts with jurisdiction in the charges for which the tickets were issued.-amended title
