A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 56-5-1535 so as to prohibit speeding in highway work zones, provide penalties, define terms, and provide for application of the Section and posting of signs; and Section 56-5-1895 so as to prohibit passing in highway work zones and provide penalties.-amended title
