A Bill to amend Sections 37-2-202 and 37-3-202, as amended, Code of Laws of South Carolina, 1976, relating to the additional charges a creditor or lender may contract for in consumer credit sales and consumer loans under the South Carolina Consumer Protection Code, so as to raise the maximum allowed assumption fee from the lesser of two hundred fifty dollars or one percent of the loan balance or unpaid debt balance or unpaid debt balance; and to amend Section 37-10-102, relating to loans for personal, family, or household purposes secured by a lien on real estate under the South Carolina Consumer Protection Code, so as to raise the maximum allowed assumption fee from the lesser of two hundred fifty dollars or one percent of the unpaid loan balance to the lesser of four hundred dollars or one percent of the unpaid loan balance.-amended title
