A Bill to amend Section 38-77-30, Code of Laws of South Carolina, 1976, relating to definitions for purposes of automobile insurance, so as to define "individual private passenger automobile" for these purposes, and to provide that specialized insurers may not cede risks to and does not recoup losses of the Reinsurance Facility and may be excused from the merit rating plan and the classification and territorial plans upon approval of the Commissioner.-amended title
