A BILL TO AMEND CHAPTER 119, TITLE 59, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO CLEMSON UNIVERSITY, BY ADDING ARTICLE 9, PROVIDING FOR CLEMSON UNIVERSITY ATHLETIC FACILITIES REVENUE BONDS; AND TO AMEND SECTION 59-121-30, RELATING TO ELECTIONS FOR CITADEL TRUSTEES, SO AS PROSPECTIVELY TO DELETE THE AGE LIMIT AFTER WHICH PERSONS ARE INELIGIBLE TO BE ELECTED OR REELECTED.-AMENDED TITLE
