**H\*3954 (Rat #0251, Act #0237 of 1996) General Bill, By Young-Brickell, Bailey, C.D. Chamblee, Davenport, Easterday, Harrison, Haskins, R.J. Herdklotz, Inabinett, Knotts, Littlejohn, Mason, Riser, Robinson, Vaughn, D.C. Waldrop and Witherspoon**

A Bill to amend Section 20-7-1670, as amended, Code of Laws of South Carolina, 1976, relating to persons who may petition to adopt, so as to further provide for specific findings the court must make in allowing a nonresident to adopt a child in South Carolina and to correct internal references; and to amend Section 20-7-1700, as amended, relating to consent and relinquishment for the purpose of adoption, so as to require consent and relinquishment to be given after the birth of an adoptee.-amended title
