A Bill to amend Section 16-11-760, Code of Laws of South Carolina, 1976, relating to unlawful parking on private property without permission, so as to provide penalties for violations, and to amend Section 56-7-10, relating to the uniform traffic ticket and the offenses charged through use of this ticket, so as to add a violation of Section 16-11-760 to the list of these offenses.
