### **H\*3986 (Rat #0294, Act #0291 of 2012) Joint Resolution, By Hayes and Bingham**

**Summary:** School districts to retain funds that are set to lapse prior to June 30, 2011

A JOINT RESOLUTION TO PROVIDE THAT, UNTIL DECEMBER 31, 2012, A SCHOOL DISTRICT MAY APPLY FOR AND RECEIVE ITS ALLOTTED SHARE OF EIA SCHOOL BUILDING FUNDS UNDER SECTION 59-21-430, CODE OF LAWS OF SOUTH CAROLINA, 1976, FOR FISCAL YEAR 2011-2012 UNDER THE TERMS AND CONDITIONS APPLICABLE TO ALL SCHOOL DISTRICTS. - ratified title
