**H\*4116 (Rat #0249, Act #0211 of 2018) General Bill, By Ridgeway, Douglas, Spires, G.M. Smith, Clemmons, Tallon and Cole**

**Summary:** Medical Practice Act

AN ACT TO AMEND THE CODE OF LAWS OF SOUTH CAROLINA, 1976, BY ADDING SECTION 40-47-38 SO AS TO PROVIDE THAT THE MEDICAL PRACTICE ACT MAY NOT BE CONSTRUED TO REQUIRE PHYSICIANS TO SECURE MAINTENANCE OF CERTIFICATIONS AS A CONDITION OF LICENSURE, REIMBURSEMENT, EMPLOYMENT, OR ADMITTING PRIVILEGES AT HOSPITALS OR FEDERALLY QUALIFIED HEALTH CENTERS IN THIS STATE; AND TO DEFINE NECESSARY TERMS. - ratified title
