Summary: Horry County Education Board, annual compensation established by; Interscholastic soccer, School districts
A BILL TO AMEND ACT 612 OF 1980, RELATING TO THE COMPENSATION OF MEMBERS OF THE HORRY COUNTY BOARD OF EDUCATION, SO AS AUTHORIZE THE BOARD TO ESTABLISH THE ANNUAL COMPENSATION OF ITS MEMBERS AND CHAIRMAN AND PROVIDE WHEN THE SALARY PROVISION IS EFFECTIVE; AND TO PROVIDE THAT STUDENTS IN ANY SCHOOL WITHIN THE HORRY COUNTY SCHOOL SYSTEM WHO PARTICIPATE IN INTERSCHOLASTIC SOCCER OR AS A MEMBER OF A SCHOOL SQUAD MAY PARTICIPATE IN ORGANIZED SOCCER WHICH IS INDEPENDENT OF THE CONTROL OF THE SCHOOL UNDER CERTAIN CONDITIONS, AND TO PROVIDE THAT A SCHOOL OR STUDENT WITHIN THE HORRY COUNTY SCHOOL SYSTEM IS NOT INELIGIBLE FOR PARTICIPATION IN INTERSCHOLASTIC SOCCER BECAUSE OF THE PARTICIPATION OF THE STUDENT AS A MEMBER OF AN ORGANIZED SOCCER TEAM.-AMENDED TITLE
