**Summary:** Flags flown at half-staff

AN ACT TO AMEND SECTION 10-1-161, AS AMENDED, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO FLAGS FLOWN AT HALF-STAFF ON THE STATE CAPITOL BUILDING, SO AS TO PROVIDE WHEN FLAGS ATOP THE STATE CAPITOL BUILDING MUST BE FLOWN AT HALF-STAFF, PROVIDE THAT THE GOVERNOR MAY ORDER FLAGS FLOWN AT HALF-STAFF WHEN AN ACT OF CONGRESS OR A PRESIDENTIAL ORDER IS ISSUED ORDERING FLAGS ON FEDERAL BUILDINGS BE FLOWN AT HALF-STAFF, AND PROVIDE HOW THE FLAGS MUST BE RAISED AND LOWERED WHEN FLOWN AT HALF-STAFF. - ratified title
