### **Similar (H 4333)**

A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 2-1-25 so as to establish the election districts from which members of the House of Representatives are elected commencing with the 1994 General Election, to designate the House of Representatives as the submitting authority to make the required submission of the House reapportionment plan contained in this Act to the United States Department of Justice under the Voting Rights Act, and to repeal Section 2-1-10, relating to election districts from which members of the House of Representatives were formerly elected.
